# RAIN OFF

## WATER REPELLENT TREATMENT FOR WINDSHIELD

### PRODUCT

**DESCRIPTION** Windshield treatment. Applied to glass, it forms a water repellent shield that encourages the water to run off and prevents the adhesion of snow and ice. It reduces wear and tear on wiper blades.  
In the event of rain or heavy downpours, the water runs off windshields treated with **Rain-off** even at around 60 km/h, ensuring perfect visibility even without the use of wiper blades. It aids the cleaning of the windshield and the removal of ice.  
One packet or trigger is sufficient for the treatment of all the exterior glass of a car of reasonable sizes: windshields, rear and side windows.

### AREA OF USE

For windshields and all exterior glass surfaces that need to be made water repellent.

### CLASSIFICATION

None.

### METHOD OF USE

Thoroughly degrease and dry the outside of the glass.  
**Applicator version:** Remove the transparent protection, rest the felt on the windshield and lightly press the bottle. Dispense Rain-off directly on the glass copiously and evenly, using the applicator provided.  
Let dry and repeat the application.  
Wait for it to dry again until it forms a film, then remove it with a damp cloth.  
**Trigger version:** spray on the windshield and distribute it evenly with a cloth or sponge, making sure to cover the entire surface.

### WARNINGS

Quickly wipe off any traces of RAIN OFF on the bodywork, moldings, and gaskets. Do not apply to hot or sun-exposed windshields. Do not apply on wiper blades.

### STORAGE

Shelf life of the product after packaging in a sealed package and stored at room temperature: 36 months minimum.
